

**Drawing for Tracks:** The drawing of the running order will be held at 9:00 A.M. for both TD and TDX tracks. The first TD track will be run at approximately 9:30 A.M. followed by the remaining TD tracks and then followed by TDX tracks.

From Rt. 17, turn right at the second traffic light (Cook Rd, Rt. 704). Continue on Rt. 704 for 2 miles until stop sign. Turn left on to Rt. 238 (Colonial National Historical Parkway).  
At the next intersection, turn right into the Visitor Center.

## NOTICE TO EXHIBITORS

**Entries close** 6:00 P.M., Thursday, Jan. 24, 2019 at the Test Secretary's residence, after which time entries cannot be accepted, canceled, altered, or substituted.

**Entries limited** to two TD (2) and One TDX (1). **TDX alternate track will be run as titling track at judges discussion.**

Bitches in season will be allowed to participate. The test secretary must be notified at least 48 hours prior to the test.

**Entry Fee:** TD \$75.00 and TDX \$125.00. Make checks payable to the Tidewater Tracking Club of Virginia. Mail AKC entry forms, certifications (TD) with fee to: Lauritz Comminaki, Test Secretary, 5212 Ambassador Drive, Virginia Beach, VA 23462-3509.

**The Drawing of Entries**, as required by Chapter 1, Section 17, Tracking Regulations will be held on Thursday, Jan. 24, 2019 after 7:00 P.M. at 5212 Ambassador Dr., Va. Beach, VA 23462. The drawing will determine which entrants will participate. It will be completely at random among all entries received. When the advertised limit of entries has been drawn, all remaining entries will be drawn for a position on the alternate list corresponding to the order in which they were drawn. The Test Secretary will notify all entrants of the results of the draw by Email.

**Refunds:** In the event that an accepted entry withdraws after the closing date to allow an alternate to replace said entry, the entry fee will be refunded within 7 days following the test. In the event an accepted entry withdraws after the closing date and there is no alternate to replace said entry, the entry fee will NOT be refunded.

**Awards:** A framed copy of the track will be awarded to each team that successfully completes their track.

I(we), acknowledge that the "Rules Applying to Dog Shows" and, if this entry is for an Obedience Trial, the "Obedience Regulations," have been made available to me(us), and that I am (we are) familiar with their contents. I(we) waive any and all claims, causes of action, I(we) might otherwise have against the AKC and any AKC approved judge, judging at this show, under AKC Rules, Regulations and Guidelines. I(we) agree that the club holding this show or obedience trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judged and to win prize money, ribbons, or trophies, I(we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the show or obedience trial premises or grounds or near any entrance thereto, and I(we) personally assume all responsibility and liability for any such claim; and I(we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death, or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. **INSTRUCTIONS**

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e. Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Dog Show Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to A.K.C. (For complete rules refer to Chapter 11, Section 3.)
